#### WTTC'S KEY MESSAGES ON COVID-19

- We are deeply concerned by the situation presented by COVID-19, particularly the loss of life so far. First and foremost, the Travel & Tourism sector remains committed to prioritising the health, safety and well-being of its customers and employees.
- Our sector is facing an unprecedented challenge, with some companies already on the brink of collapse. At this time, WTTC

- WTTC is calling upon all governments to take drastic and decisive action now to prevent this global health crisis becoming a worldwide economic catastrophe, and to preserve and protect the contribution of the Travel & Tourism sector. Doing nothing is not an option.
- The vast closure of hotels, suspension of the majority of international and domestic airline flights, cessation of cruise lines and growing global travel bans are having a catastrophic 'domino effect' hitting huge numbers of suppliers worldwide.

- 3. All government taxes, dues and financial demands on the Travel & Tourism sector need to be waived with immediate effect at least for the next 12 months.
